1. To delete the following, existing five (5) objects:

- (a) TO advance the cultural and social interests of the summer and permanent residents whose property has frontage on Chandos Lake or is in the immediate vicinity of Chandos Lake;
- (b) TO promote aquatic and other physical activities among the said residents;
- (c) TO promote the facilities necessary for the maintenance of the safety and health of the said residents;
- (d) TO help provide the best and most efficient government and legislation for the benefit of all residents; and
- (e) TO solicit and receive funds and contributions for the accomplishment of the above objectives.

And replace with the following, new four (4) objects:

- TO maintain, protect, and improve the quality of Chandos Lake and its watershed, including through education as well advocating on land use management and water quality issues, as appropriate
- TO promote, where feasible and appropriate, safe practices in and around the lake
- TO provide a means of communication amongst members and between the corporation and the membership
- TO advance the social and cultural interests of members and the local community, including the provision of occasional financial support to local charities, non-profit organizations, events or initiatives.

2. To change the location of THE HEAD OFFICE of the Corporation from "The Municipality of Metropolitan Toronto" to "The Province of Ontario".


