I understand that during my participation or my child's participation in the above event, I and/or my child will be exposed to a variety of hazards and risks, both foreseen or unforeseen, through my involvement in the event ("risks").

The risks include, but are not limited to, the danger of serious injury to my person or property, or my death ("injuries and damages"). I know that injuries and damages may occur by natural hazards, by the acts or omissions of other persons, or for other reasons. I further understand that injuries or damages may result through **negligence**, **gross negligence**, error, mistake or wrongdoing by other parties, including by the Chandos Lake Property Owners Association, or by third parties, or for other reasons. I understand that I must exercise due care for my own person and for those around me given the risks of participating in the event.

In consideration of my permission to participate in this event, and to use the services and amenities provided by the CLPOA or by third parties in connection with the event:

I knowingly, voluntarily, and freely assume all risks, both known and unknown, and hereby waive, release and discharge the CLPOA and/or its officers, directors, employees, agents and volunteers, and all property owners or occupiers of property on which the event is held, from all causes of action or claims of any kind for injuries and damages sustained by me, or any minors in my guardianship, however they may arise, including injuries and damages arising from the negligence, gross negligence, error, mistake or wrongdoing of any party or person, and assume full responsibility for my participation in the event;
